Composition:

Each 100 g contains:

Aqua, Sodium Lauryl Ether Sulphate IP, Coco Amido Propyl Betaine IP, Glycerin IP, Sodium PCA IP, Disodium EDTA IP, Activated Charcoal Powder IP, Potassium Sorbate IP, Aloe Vera Extract IP, Phenoxyethanol IP, Fragrance q.s.

Therapeutic Segment:

Skin Care / Facial Cleansing Segment

Therapeutic Indication:

Indicated for daily facial cleansing to remove dirt, excess oil, and impurities.

It helps in unclogging pores, reducing acne-causing bacteria, and leaving skin feeling refreshed and clean.

Mechanism of Action:

- Sodium Lauryl Ether Sulphate and Coco Amido Propyl Betaine act as gentle surfactants to remove dirt and oil.
- Activated Charcoal Powder adsorbs impurities and toxins from the skin surface.
- Glycerin and Sodium PCA provide moisturizing and hydration.
- Aloe Vera Extract soothes and calms the skin.
- Preservatives (Potassium Sorbate, Phenoxyethanol) maintain product stability and prevent microbial growth.

Dosage & Administration:

- Apply a small amount of facewash to wet face.
- Gently massage in circular motions for 30–60 seconds.
- Rinse thoroughly with water.
- Use once or twice daily or as directed.

Contraindications:

- Hypersensitivity to any ingredient in the formulation.
- Avoid contact with eyes; in case of contact, rinse immediately with water.

Warnings & Precautions:

- For external use only.

- Discontinue use if irritation, redness, or allergic reaction occurs.
- Keep out of reach of children.

Side Effects:

- Rarely may cause mild irritation or dryness in sensitive skin.

Storage:

Store in a cool, dry place below 30°C.

Keep the cap tightly closed to prevent contamination.
